I agree that until I have actually paid for the time, the space is not officially reserved. Once I have paid for the space, I agree that my rent is non-refundable without a two week notice. The rent that I am paying per hour allows me 10 minutes on each side of the hour that I am renting for people coming and going. All time rented is at a minimum of an hour. If I start my class late, I am aware that I still need to end the class at the original time. Any set up time that I need or want needs to be in that hour or done quietly with out disturbing any other class that may be going on at the studio. I am aware that this rent does not include the use of equipment at the studio or storage for my business requirements. The Upper Valley Dance Alliance is not responsible for advertising or publicizing my class. If I want to be included in the

News Letters or Mailings, I have the right to buy a spot at a minimal charge. The Upper Valley Dance Alliance has the right to renegotiate rental prices at anytime with a two week notice.

I agree that it is my responsibility to ensure that my customers do not wear street shoes in the dance space under any circumstances. I will take the time to remind my students and to ask them to remove there shoes should I see them wearing them on the dance floor. At the end of my class, I will check the rest rooms and make sure that they are clean and that everything is stocked that needs to be.
